



For some, the death of loved ones, for others the loss of a job, or maybe not being able to meet up with friends causing loneliness, and for many of us not being able to worship together in church. In our daily lives Daphne and I have been greatly blessed by neighbours who have cared for us by collecting prescriptions, doing supermarket shopping, and collecting milk and greengroceries from the farm shop. Our children have still been able to keep in touch by telephone, and our youngest daughter has got us using Skype !! Through TV we have been able to join in the services at Cathedrals in Bangor, Hereford and St David's and also at a church in Manchester. I have been able to read the emails from Bishop Martin, and eventually re-join Benefice Services through live streaming. I shall have to concentrate on improving my I.T skills !!

Over the past few weeks we have been able to have visits from each of our children. We have had haircuts at last and a visit to the chiroprapist and began to do some of our own shopping. Our services have started again in church, subject of course to the rules. So, we are beginning to settle into a new normal.

During lockdown I have survived a rather lethargic period and have been able to read more. The most helpful book has been one I used when training as a Reader. It's called "The Path to Glory" thank you (studies in St Luke's gospel). I believe that whenever we read the story of Jesus, we are led to what's important in life. We are reminded of the loving father who wants us to have life, and have it in all fullness.

Jesus summed it up in the words, love God and love your neighbour. Despite all the ups and downs, we are still able to do both.

Phylliss Marjorie Planton's 100th Birthday - 2nd August 2020

Phylliss was born in Stanton on 2nd August 1920 being the 3rd of 7 children to Ellen and Reginald Cammell. The family moved to Barningham in 1925 and then on to Hepworth 3 years later at the age of 8 where she has lived ever since. In the year 1940, aged 20, Phylliss left the family home in Red House Farm North Common Road to join the war effort in Lincolnshire at RAF Cranwell where she spent 5 years.

A year after leaving the RAF Phylliss married Frederick Planton and went on to have 4 children, Brenda, Lawrence, Malcolm and Jennifer. The family moved to 11 The Street in 1950, then on to 12 The Street in 1968 before moving to 15 The Street where Phylliss lives to this day. She has lived alone for 42 years following Fredericks passing on the 6th April 1978.

As well as raising her family Phylliss worked on the local farms doing casual labour before spending 15 years at the local Mushroom Factory. Phylliss is a very loving Mum, Grandma and Great Grandma, and is dearly loved by all. Apart from the family Phylliss loves going out whenever possible, and prior to lockdown was still spending her Monday evenings with her friends at Stanton bingo.

Due to the Corvid 19 regulations the family celebration had to be held outside her bungalow but they had obviously put a lot of loving thought and effort into this as the gazebo was beautifully decorated with flowers, banners and, in pride of place, the birthday card from the Queen. The sun shone and Phylliss also had visits from village friends, and it was lovely to see her so happy and surrounded by so many generations of her family. Nothing had been overlooked and I was sent home with one of their boxed cream teas - thank you, Plantons

My personal endearing memories of Phylliss go back to my being a young teenager in the early 60s when one of the highlights of village life then was the Annual Church Fete. Reverend Radice always organised the 'Ladies Ankle Competition' (obviously different era!) as a bit of fun and we lined up behind a screen for judging- Phylliss usually won but I managed to win once but probably because she was not there.

I always recall her being very lucky with winning draw prizes there and one of my sister's very earliest memories is of our mother running a 'name the doll competition' and foolishly letting Jane hold the doll in her pushchair - Phylliss correctly guessed the name and, of course, there was a lot of tears from my sister when she had to give it up! I hope this luck has followed Phylliss to her bingo sessions.

Being Hepworth's oldest resident, Phylliss has willingly helped with commemorating special events in the village such as tree planting, and as the new village sign will soon be due to be installed will you be up for that as well please, Phylliss?

These are my special thoughts of a wonderfully independent 100 year old but on behalf of everyone in Hepworth may I wish her continued good health and happiness with her large and loving family.

4 Update on Hepworth Recreation Ground Committee: The hall now has a notice on the door which says that it is closed for decoration and repairs. The playground remains closed until repairs have been completed. The work has been contracted out according to the Treasurer. There should be 5 trustees according to the lease agreement, but only 4 exist. The Charities Commission web site names them however two names are the same, are they the same person? This needs to be clarified. Cllr N Yorke received an email with a link to Suffolk ACRE document about how to re-open a recreation hall following Covid 19. L Robinson spoke with the Treasurer of the recreation committee to ask a for information about the COIF fund. It is unclear what the original terms of the bequest were. Correspondence will be found to confirm this. There was concern that there had been some minor upset between HRG and the Clerk, however this was dealt with at the time. The PC recognise that they have a duty of care towards their employee and they take the responsibility seriously. The Councillors unanimously agreed to ask NALC for their legal representative's advice on the current situation and subsequently if necessary, to ask the Charities Commission to investigate.

HEPWORTH PARISH COUNCIL: MINUTES

2. Declarations of Interest: There were no declarations of interest

3 Resolution to Exclude Press/Public: Not required as none present

4 Update on Hepworth Recreation Ground Committee: The play area is undergoing refurbishment and looks really good. It is almost complete. The Redecoration of the pavilion building will be next. A Solicitor has been contacted regarding the Lease agreement between Hepworth Recreation Ground Committee (HRG) and the Parish Council (PC). It would cost somewhere in the region of £750 plus VAT for the Solicitor to examine the lease and provide advice around the perceived breaches. The Treasurer of HRG has provided some account information however, a break -down of payments made covering the entire period from 2012 to date is still needed in order to explain expenditure from the COIF account and the Treasurer has indicated that this will now be provided. Discussion around potential options in relation to the HRG. Resolution passed to seek legal advice in order to establish lawful options available.

HEPWORTH PARISH COUNCIL: DRAFT MINUTES

A meeting of the Hepworth Parish Council took place on Thursday 2ND September 2020 at 7.30pm. The meeting was conducted via video link and the following items were discussed.

Attendees Ms L Robinson (Chair), Mrs N Yorke, Mr A Yorke, Mr G Bloomfield, Mr R Marsham, Mrs M MacPherson, Mr R Shackleton, Cllr Spicer, Cllr Bull, Clerk Ms H Corris

No members of the Public were present:

1. Apologies: There were no apologies.

2. Declarations of Interest: There were none

3. To Consider requests for dispensations: None received

4. Minutes of previous meetings: The minutes of the Meeting 02/07/20 & 24/7/20 & 20/08/20 were agreed to be a true record.

5. Cllrs Reports: Cllr Spicer advised that Unsuitable for HGV signs will be sighted at the

junction of the A143 and at the junction of the B111 and Hepworth Road in Barningham. Three traffic counts have been completed in the village over the summer. Full results not yet received however it is apparent that Hepworth has a massive speeding problem. County council consider the issue to be so significant that it merits an intervention by them. Hepworth PC will be major consultees in the process that follows and the Speedwatch team will also be part of that consultation. There are a variety of interventions that can be considered to calm the speed of the traffic and Cllr Spicer will come back to us with options. The PC thanked Cllr Spicer for the investment made into this matter so far. The Bus shelter refurb will be covered by funds from both Cllr Spicer and Cllr Bull. If there is to be any action taken by the PC in relation to the lay-by/verge outside the Havebury Bungalows in The Street then permission must be obtained from S.C.C beforehand. Shepherd's Grove Development is still on-going however the owners/developers are looking at an alternative plan that would not involve any housing being built. The current plan is being delayed by an issue over ownership of an area of land within the proposed development. Cllr Spicer has made enquiries with the organisation responsible for public rights of way and footpaths as she noticed the field in Wood Lane had not had the footpath between Wood Lane and Beck Street opened up and that it was still full of a crop. The man-hole cover in The Street that belonged to Anglian Water did not meet the County council criteria for an intervention and she recommended that complaints should continue to be logged and that PC should write to Anglian water.

Councillor Bull; There have not been any plans submitted to WSC in relation to Mill House. She has passed the matter on to the enforcement team as a ditch has apparently been filled in and there is concern about access onto the A143. She will feedback to the PC. Cllr Bull confirmed she will assist with the cost of the bus shelter refurb and has received documentation from the PC. The Cart Lodge and Annexe planning queries have been looked into thoroughly and numerous site visits have now been made. An application was approved retrospectively for the properties that have been used as holiday lets for many years now. Another application that was made recently was for a separate building. Planners will however, investigate the matter of whether some other buildings are now being used as dwellings and feedback to the PC. There have been a lot of Anti-social behaviour at Knettishall Heath recently and she has been working in conjunction with the Police and other partners to address the issues. A question was asked regarding Tree preservation orders and advice provided that all TPO's are available to be viewed publicly on the WSC website.

6. Progress reports on previous meeting actions: The Parish Council finally has a debit card so online purchases may now be made. The Flint arrow /axe head issue has not progressed at this time but once the Pavilion is re-opened it is hoped a display box will be installed. The Village sign and mounting post has been ordered. There is a three month wait. The proposed location is on the same side of the road as the Village map but on the other side of Wood lane. This will enable the sign to be seen clearly by traffic travelling in both directions along the street. There is currently a large Sycamore tree growing out of a ditch that will have to be trimmed to avoid interfering with the new sign. The Clerk will speak to two local builders and obtain quotes for the sign installation. The two bus shelters will be re-painted and one will have new roofing felt. The Play area at the Pavilion looks great, almost finished. Work has also begun inside

the Pavilion Not known when it will be finished. Clerk to make an enquiry regarding this. General discussion regarding consulting a Solicitor regarding the lease between PC and Hepworth Recreation Ground Committee. Documentation has been provided in relation to income and expenditure for the period 2011-2019. Two quotes have been received in relation to the verge outside the Havebury bungalows in The Street. Both were around the £3000 mark. This is currently beyond the budget of the PC at this time so a consultation with the residents will not go ahead.

7. Clerks update RFO Reports: Bank Balances as of 19.8.20 Community Account £12176.32 Less unrepresented cheques £11819.32 Reserve Account £1836.98 Receipts and Payments There were no receipts in the last month. The following payments were authorised Cheque 999 £448.04 Clerks July pay and expenses Cheque 1000 £227.59 Clerks August Pay and expenses Expenditure against Budget Review Total income to date £7675 Comprises: Precept £7205 Refund on Hornbeam Purchase £286 VAT refund £184 Anticipated underspend in some areas of the budget. Potential expenditure on Solicitors fees of up to £1000 which was not originally anticipated. Expenditure on Village sign (partly funded by Cllr Bull) remainder to be covered by PC. Review Internal Audit/ Impact Assessment The Audit report has already been accepted at a previous meeting but the following actions have now been implemented. The Asset register has been recalculated to the value of £29,187 The Recommended suite of GDPR documents published by SALC will be utilised. Further clarification will be sought as some recommendations do not appear to apply to the PC. Model Financial Regulations 2019 The PC have reviewed the above documentation and have now adopted the 2019 version replacing the current 2013 version as recommended by the auditors
 8. Maintenance Team Resolution not to explore the costs involved regarding a regular maintenance contract for the upkeep of hedges and verges etc in the Village due to the difficulty of establishing who the lawful land owners were in many cases. In the past the goodwill of the residents has been relied upon to keep the Village looking tidy. This does not appear to be as effective as it used to and areas are looking unkempt.

July 2020: An often cloudy, rather sunless month. Temperature and rainfall were around average, although most of the rain fell in the first half of the month. On the 4th and 5th there were unusually strong winds for the time of year, with frequent gusts between 35 - 45mph. On the 31st there was a remarkable 'heat spike' with a hot SSE wind blowing from Europe and a maximum temperature here of 33.2°C. Unusually, there were no thunderstorms here during the month.

August 2020: A warm, wet month with some very warm nights. From the 7th to the 12th, apart from the 8th, there were 5 days with maximum temperatures above 30°C. Very thundery on the 16th with very heavy rain in a short space of time. 22.9mm fell in 15 minutes around midday! On the 25/26th, in the wake of storm 'Francis', a wind gust of 60mph was recorded here with frequent gusts between 40 - 50mph overnight. A record for August.

#YourFuture #YourSay on West Suffolk Local Plan

People's views will be at the heart of forming a new Local Plan for West Suffolk, which will help shape the future of communities, and supporting development up to 2040.

The Local Plan helps local communities continue to thrive in the future by setting out where homes will be built and supports where new jobs and other vital facilities are located. All West Suffolk planning decisions are judged against Local Plan policies.

The Local Plan ensures the right number and types of homes are built in the right places, and through its policies supports the provision of space for employment, green spaces, education, culture, health and sports facilities. It also looks at how infrastructure supports this growth and challenges faced in the area, such as climate change.

It is also vital to prevent speculative development that could harm local communities and the environment. It ensures growth is well planned and supports future ambitions for the future.

The process involves three consultation stages with the first being 'Issues and Options' which will start in October and last for 10 weeks.

This initial stage will help shape the plan and the future of West Suffolk as it develops. The 'Issues and Options' stage has three parts: Part One includes a vision for West Suffolk for the plan period to 2040 and a new draft settlement hierarchy; Part Two sets out issues in West Suffolk that are particularly relevant to our area; Part Three contains sections for the towns, key service centres, local service centres and villages identified in the draft settlement hierarchy in part one of the plan.

At this first information gathering stage, the council will be consulting and seeking comments on a variety of issues and options. This includes questions such as have we identified the challenges correctly, relevant local issues, is the settlement hierarchy right, and is it in the right place.

Due to COVID-19, engagement on this will naturally be different to before the pandemic. There will be a range of ways people will be able to see the information, find out more and have their say, including a virtual exhibition online. As and when guidance changes on social gatherings, the engagement methods will change to be as accessible as possible.

We want everyone in and beyond West Suffolk to be involved in preparing your new local plan.
