

Dear Friends & Neighbours

The month of June with its promise of Summer is traditionally the beginning of the wedding season... and I'm excited to have six weddings across the Benefice in my diary for this summer.

HEPWORTH PARISH COUNCIL - MINUTES OF PARISH COUNCIL MEETING HEPWORTH PAVILION THURSDAY 20 MARCH 2025 @ 7.30pm

PRESENT: Councillor Garry Bloomfield (GB) (Chair), Councillor Nicholas Bennett (NB) (Vice Chair), Councillor Perry Penn (PP), Councillor Louise Robinson (LR), Councillor Hollie Williams (HW)

IN ATTENDANCE: Six members of the public 25/25 DECLARATIONS OF INTEREST: None.

25/26 APOLOGIES: Cllr Marjorie MacPherson sent apologies which were accepted. 25/27 PUBLIC FORUM: DC/24/1622/FUL. Members of the public highlighted a range of concerns relating to this planning application:

- Management It was not clear how the proposed business would be managed on site to reduce risk of noise or traffic disruption to nearby properties.
 - Opening Hours The opening hours were viewed as excessive.
 - Lighting Proposed lighting was considered disproportionate.
- Fencing Proposed fencing around the site would impact on local rural landscape.
- Noise There was concern that a 2nd dog business operating next to an existing dog business would increase risk of noise.
- Location The proposed location was next to existing properties whereas alternative locations on the applicant's land could reduce such proximity.
- Access There was concern that the proposed access would not cope during winter months and cars would be parked on the main road.

District Cllr Carol Bull arrived at 7.55pm

County Cllr Joanna Spicer arrived at 8.00pm

- 25/28 REPORTS FROM AND QUESTIONS TO BOTH DISTRICT AND COUNTY COUNCILLORS: County Cllr Spicer provided the following update:
 - Devolution. The ongoing public consultation for proposed Norfolk and Suffolk Mayor was highlighted. Elections for the Mayor would take place in May 2026.
 - Bus Shelter. County Council support for bus shelter changes was available. It was agreed that LR would meet with County Cllr Spicer and an officer from the County Council transport team to discuss the aspiration further.
 - County Farms. Discussions were still ongoing in relation to ditch clearing by a tenant of County Farms.
 - Western Lane. The restoration of Western Lane has now been completed. Concerns were raised about continued presence of glass and the Parish Council would monitor the lane in the future.
 - Allotments. LR enquired whether there was any County Farms land available to provide allotments for the village. County Cllr Spicer agreed to discuss this further with County Farms

District Cllr Bull provided the following update:

• Local Government Review. Two different Suffolk options were going forward as part of Local Government Review work; the County Council was proposing a single unitary authority while the 5 District/Borough Councils were presenting an case for two or three Unitary Authorities.

- County Cllr Joanna Spicer left at 8.30pm District Cllr Carol Bull left at 8.30pm
- 25/29 MINUTES OF THE PREVIOUS MEETING: Minutes of the meeting held on 20 February 2025 had been previously circulated and it was resolved that these were an accurate record of the meetings.
- 25/30 MATTERS ARISING FROM THE MINUTES: No matters arising were identified from the last meeting that were not included in the agenda.
- 25/31 HIGHWAYS MATTERS: No matters discussed.
- 25/32 FINANCE AND ADMINISTRATION: Finance Report. The meeting noted the finance report (current account balance £4,230.11, savings account balance £7,000.00 and the projected outturn at the end of the FY of approx. £3,200 current account and £7,000 savings account). The following payments were authorised: Noticeboard Company £36.24; Clerks Salary & Exps £985.20; Louise Robinson (Flowers) £17.99. LR agreed to authorise the first two payments and NB agreed to authorise the last payment.
- 25/33 PLANNING MATTERS: DC/24/1622/FUL. Considering the earlier public comments on this planning application, the meeting agreed to submit a HOLDING OBJECTION and to seek clarification of certain details that currently prevented a final position to be resolved:
 - Location Why was the location chosen close to existing properties when alternatives were available?
 - On Site Management Further detail is needed on how the dog business will be managed on site to reduce community impacts.
 - Hours of Operation Why does the business need to operate from 6am to 9pm, 7 days a week?
 - Access What highways and associated works are needed to provide safe allweather access and what transport assessment has been undertaken to quantify traffic impacts?
 - Local Landscape What mitigation is planned to reduce the visual impact of the proposed site, particularly the new fencing?
- 25/34 CORRESPONDENCE:
 - a. West Suffolk Local Plan Modification. The meeting noted the previously circulated email covering West Suffolk Local Plan Modifications.
 - b. Review of Litter Bin Collections. The meeting supported the proposed changes by West Suffolk Council that had been pre-circulated subject to:
 - The new bin at the pavilion gate being relocated to the other side of the entrance to avoid blocking the road.
 - The litter bins in the bus shelters being left and these will be emptied via local arrangements.
- 25/35 QUESTIONS TO THE CHAIRMAN: None
- 25/36 DATE OF NEXT MEETING: It was agreed that the next Parish Council meeting will be on Thursday 17 April 2025 at 7.30pm.
- The meeting closed at 9.15 pm.

IN ATTENDANCE: Andy Osman (Parish Clerk) (AO), District Cllr Carol Bull (CB), Eleven members of the public

25/37 APOLOGIES: Cllr Hollie Williams sent apologies which were accepted.

25/38 DECLARATIONS OF INTEREST: LR declared an interest in Item 9b, Planning Application DC/25/0511/CLE.

25/39 PUBLIC FORUM: DC/24/1622/FUL. Members of the public highlighted a range of ongoing concerns relating to

this planning application:

- Management It was not clear how the proposed business would be managed on site to reduce risk of noise or traffic disruption to nearby properties.
 - Opening Hours The opening hours were viewed as excessive.
- Lighting Proposed lighting was considered disproportionate to rural setting..
- Noise There was concern that a 2nd dog business operating next to an existing dog business would increase risk of noise.
 - Location The proposed location was next to existing properties.
- Parking & Traffic-There was concern that cars would be parked on the verge and that persons using the site would add considerably to the traffic flows on roads where large sections are single track. Safety concerns in relation to the Beck Street junction and residents driveways were also raised.
- Stanton Rides additional traffic and proximity to bridleways would deter riders.

County Cllr Spicer arrived at 8.10pm

25/40 REPORTS FROM AND QUESTIONS TO BOTH DISTRICT AND COUNTY COUNCILLORS: County Cllr Spicer provided the following update:

- County Farms. Discussions were still ongoing in relation to ditch clearing by a tenant of County Farms. It was agreed that JS would report the outcome of discussions at the next Parish Council meeting.
- Allotments. The meeting acknowledged that it was unlikely that land would be surrendered from County Farms areas. LR agreed to write an article for the Hepworth Herald to gauge support for allotments.
- Weston Lane. Suffolk Rights of Way have acknowledged that the new surface still has small pieces of glass coming through. It was agreed to arrange a meeting with County Cllr Spicer and Rights of Way to discuss the issue further.
- Planning Application DC/24/1622/FUL. It was noted from the public forum that the Suffolk Highways response to this application had not considered Stanton Rides. CB agreed to discuss this issue with the case planning officer. District Cllr Bull provided the following update:
- Bin Collections. Changes to bin collections over Easter were highlighted. 25/41 MINUTES OF THE PREVIOUS MEETING: Minutes of the meeting held on 20

- March 2025 had been previously circulated and it was resolved that these were an accurate record of the meetings.
- 25/42 MATTERS ARISING FROM THE MINUTES: Minute 25/28: 20 March 2025 Buses. LR reported some problems with the new bus taking pupils to school being late. This was thought to be caused by not enough time being put into the schedule to take fares. It was highlighted that Suffolk County Council had commissioned consultants to look at future bus options. The meeting noted a request for future funding for bus timetables. LR reported that a meeting with the County Council to discuss the proposed relocation of the bus shelter would take place on 30 April.
- 25/43 HIGHWAYS MATTERS: No matters discussed.
- 25/44 FINANCE AND ADMINISTRATION: Finance Report. The meeting noted the finance report (current account balance £3,190.58, savings account balance £7,000.00 and the projected outturn at the end of the FY of approx. £3,200 current account and £7,000 savings account). The following payments were authorised: SALC Membership £269.90; SALC Payroll £22.80; NB agreed to authorise the payments.
- 25/45 PLANNING MATTERS: DC/24/1622/FUL. NB highlighted continued inconsistencies in proposed use following the supplementary information provided by the applicant to the Parish Council's points of clarification, eg states no intent to operate after dark and yet retains proposals for lighting and hours of operation 6am to 9pm. The meeting resolved that there were still material issues:
 - Traffic. There would be increased traffic on a narrow lane with potential safety issues for existing users.
 - Lighting. The proposed lighting would impact a currently dark rural area.
 - Loss of Amenity. The operation would increase noise for neighbouring properties.

The meeting agreed to OBJECT to the application.

- DC/25/0511/CLE. The meeting agreed to offer no comment on this application. DC/25/0361/ADV. The meeting noted that the proposal was disproportionately larger than other signs in the area and agreed to offer this as a comment along with SUPPORTING the application.
- 25/46 CORRESPONDENCE: None
- 25/47 QUESTIONS TO THE CHAIRMAN: 'The Stables'. NB asked the Chair if CB could provide an update re "The Stables". CB updated the meeting on the ongoing monitoring of 'stables field' from a planning enforcement perspective and confirmed that the status of the field needed to be clarified. NB and CB agreed that if it is classified as agricultural land, the existing works could constitute unlawful development. CB agreed to clarify the status of the field, thought to be agricultural use only, in relation to the development thus far.
- 25/48 DATE OF NEXT MEETING: It was agreed that the next meeting will be the Annual Parish Council Meeting on Thursday 15 May 2025 at 7.45 pm. This will follow the Annual Parish Meeting which starts at 7pm.

The meeting closed at 9pm.

- 25/56 RISK ASSESSMENT: The financial and asset risk assessment, previously circulated, was considered. It was resolved to approve this assessment.
- 25/57 FINANCE AND ADMINISTRATION:
 - a. Finance Report. The meeting noted the finance report (current account balance £9,646.52, savings account balance £7,000.00 and the projected outturn at the end of the FY of approx. £3,200 current account and £7,000 savings account). The following payments were authorised: Hepworth Pavillion Hire £72.00; Malcolm Saunders (audit) £90.00; It was agreed to seek authorisation from Cllr Louise Robinson for the payments.

its gross expenditure for 2024/25 did not exceed £25,000. It was resolved that the Clerk was to return the signed Certificate of Exemption.


